APPLICATION

FOR DAILY MOPPING:

Dilute CERAMI-SHEEN at a rate of 1 oz. per gallon with cool to warm water for light to moderate soil (no rinse required at this dilution), to 2-3 oz. per gallon of cool to warm water for heavier soil. Scrub surface with mop; in heavy soil conditions, a light rinse with clean water is recommended.


